"On CP 801 Blocks 4 & 5, Brian Barton, a retired RPF, helped us market the wood in Quesnel Weldwood for our Peelers for \$ 97 / m<sup>3</sup> at a 780 conversion rate which is excellent. And 100 Mile Weldwood for our Sawlogs for \$ 71 / m<sup>3</sup> at a 750 conversion rate which is excellent because it really means \$ 75 / m<sup>3</sup>"

"BCL applied for a Tender or I mean Bid on 48,000 m³ (Stump to Truck) with Weldwood August 3, 1999. We bid \$ 14.25 m³ for short logs and \$ 13.25 m³ for long logs"

Northern Secwepemc te Qelmuc aka NStQ aka Cariboo Tribal Council 'treaty' Society aka CTC't'S

"...from an accounting perspective, we (Bursey & Pateman) wouldn't recognize that company's (WLIB's Borland Creek Logging) earning potential { (FL A51220 - 75,000m³) @ +/- \$10 / m³ profit even <u>after</u> \$45/m³ 'bc' stumpage = +/- \$ 750,000 <u>WLIB BAND REVENUE</u>}" – Brent Bursey, CGA, WLIB / Pateman & Bursey

"What about 'treaty'...you listed this \$12,000 as surplus but each and everyone of us here knows that is not true. In fact, that is actually probably about a (1) million twelve thousand dollar loan that we (WLIB's 25% portion of CTC't'S *loan*) owe. That (\$12,000 SURPLUS) is not true, you should attach a one million (DEFICIT) in front of that twelve thousand" -- WLIB Band Member

"I wouldn't mind addressing that. That is a fair comment" - Brent Bursey, CGA, WLIB / Pateman & Bursey

"In the financial statements we do address that and from MY perspective... I would... think that there is an issue there. What we say in the financial statements in the whole package and it is in what's called NOTE 10. We actually treat it as a **contingent liability**. That means, we consider that there is some uncertainty and exactly how that would (make?) up. What we disclosed in here is... and the CTC 'treaty' Society has represented to us... that they don't consider there is any direct liability on the bands behalf. Certainly I've had... and... I've taken some issue with that... from time & I guess our ah...for lack of a better word... I guess...where I've ended up on it is... is not to actually disclose the loan, but to provide the details of that situation & we say; In here, the CTC't'S signed an agreement on behalf of it's member bands with Canada and 'bc'. The CTC't'S has received loans pursuant to an agreement with the bc't'c which are repayable upon the (INAUDIBLE) of, and there are a number of conditions here & it's:

- -the 12<sup>th</sup> anniversary of the day of when the first loan transfer was made, ( December 13, 2005 ? )
- -the 7<sup>th</sup> anniversary of the day of the signing of an AGREEMENT IN PRINCIPLE, ( 2010 ?)
- -it's the day on which the 'treaty' is signed by the parties, (2010?)
- -the day on which the 'treaty' agreement is terminated" (November 22, 2001 FAILED WLIB "treaty' REFERENDUM?)

"They've (CTC 'treaty' Society Directors) taken the position the liability doesn't flow to the bands..." – Brent Bursey, CGA, WLIB / Pateman & Bursey

"I'm not a lawyer. Their position is, and they ( CTC't'S) have represented to us, that they ( CTC't'S) have legal council that suggests that they have a defensible position, that that liability would not flow to the band" – Brent Bursey, CGA, WLIB / Pateman & Bursey

"It would stop with the ( CTC ) 'treaty' Society?" - WLIB Band Member

- "...we don't have a position... As I've tried to explain to you, we're not an arm of the government in the sense that we're not a political arm, we're not out here to enforce the provincial government's mandate. If the court... Before we get told to go in and deal with a situation..." -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "Let's talk about **DELGAMUUKW**" -- WLIB MEMBER
- "That's what I was just going to talk about..." -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "Who told you DELGAMUUKW doesn't apply Bruce? Who was the exact Commanding Officer who told you that?" -- WLIB MEMBER
- "Nobody told me that <u>DELGAMUUKW</u> doesn't apply. It's <u>my</u> interpretation of how I do my job that says <u>DELGAMUUKW</u>... Like, if I stop someone on the highway..." -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "OK, How do you come to that conclusion then Bruce?" WLIB MEMBER
- "Because <u>DELGAMUUKW</u> is dealt with in a court situation... So... If you say... 'This...that piece of property over there is WLIB traditional land I'm going to go and log that land because that's my traditional land' If you say that, and you go log that land and MoF comes in and give you a stop work order... then what I hope you would do is take that stop work order and go to court with the MoF and say we've got <u>DELGAMUUKW</u> and we have all of these things on our side that should be put in front of a judge and a judge would look at their case, look at your case and would say... And would judge which one is right. At the end of that whole process, if MoF wins the court case its very likely they're going to get an enforcement order that tells the RCMP of whichever police force has the jurisdiction wherever this is occurring to go in and enforce the enforcement order..." CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "Do they (NDP, MoF & RCMP) have the right to impose (Provincial) Law on us while this is still before the court?" -- WLIB MEMBER
- "That is the ( PROVINCIAL ) court I'm talking about, that is the ( PROVINCIAL ) court that would make the order...The MoF cannot order us to go in and do something. We can monitor it, we can keep the peace, we can make sure people aren't killing each other. But we will not go in and deal with

- a political issue like that until a court has made a decision on what... who's right and who's wrong... when the court makes that decision, they make an order..." -- CTC / WLIB / RCMP Native Puppet Constable Bruce Bellieu Coles
- "Well, DELGAMUUKW already says that Aboriginal Title..." -- WLIB MEMBER
- "It has to be done on an individual basis... it cannot..." -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "Who told you that?" -- WLIB MEMBER
- "From what I read. That's my interpretation of what I read" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "And I've asked you to go back and get a position from your superiors on that. Because it sounds like you're saying that (CANADIAN) supreme court rulings do not apply to you and I am saying that they do and I'm saying..." -- WLIB MEMBER
- "I talked to my superior last night about it" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "Which one?" -- WLIB MEMBER
- "Well, (Williams Lake RCMP Detachment Commander Bob) McIntosh is my boss" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "So you talked to Bob McIntosh about this, OK" -- WLIB MEMBER
- "...About <u>DELGAMUUKW</u> and we're in agreement, we're thinking along the same ways that is" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "So you take the word of a superior that <u>DELGAMUUKW</u> doesn't apply..." -- WLIB MEMBER
- "What you've told me sitting here; You've had a verbal discussion with your Commanding Officer of a federal police force and **he said** that <u>DELGAMUUKW</u> doesn't apply. He did not give you any RCMP position from his higher ups to enforce this and you're taking his word at that?" -WLIB MEMBER
- "Can I request that you go back and get a hard copy from 'E' Division where Bob McIntosh gets that information or ask him where he gets it?" -- WLIB MEMBER
- "We're not under Kamloops anymore. We're under Prince George. Mike Morris is the Superintendant of this whole area. We're part of Northern BC now not Kamloops" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "Maybe Mike Morris should come down here to a band meeting...on videotape. Is that how we have to conduct good faith negotiations?" -- WLIB MEMBER
- "So, lets get back to McIntosh...There was no hard copy that he could give you of the RCMP stating that his position from his higher-ups that <u>PELGAMUUKW</u> does not apply to the RCMP?" -- WLIB MEMBER
- "I'm a police officer and I have to form my grounds to do anything on the information that I have" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "But you're talking about selective application of the rule of law on your own prejudice" -- WLIB MEMBER
- "How am I saying it's selective?" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "Because you're not asking your boss for a hard copy of how <u>DELGAMUUKW</u> doesn't apply to a federal police force. You're trying to interpret <u>DELGAMUUKW</u> as one human being, as a constable. That cannot be done by you. That has to come from your superiors" -- WLIB MEMBER
- "The way the RCMP works and I'm sure that it's the same that every police force works...that <u>DELGAMUUKW</u> is civil law. It's not based on criminal law. If something happens in the court system that impacts the way I do my job or have to do my job, policy comes down and RCMP policy or any police force's policy changes based on court cases or what precedents are set in higher courts. If <u>DELGAMUUKW</u> had an impact on the way I do my job I would be directed through RCMP channels, through division policy makers (ie) that is how you have to interpret <u>DELGAMUUKW</u>" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "And you haven't got that hard copy yet? Right?"
- "I don't have to go and research everytime case law is made at civil or criminal court level, I don't have to go out and check into all of these things. An organization changes RCMP policy, that policy comes down..." -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "Who is that organization?" -- WLIB MEMBER
- "E' Division. The headquarters and it would be even go up higher. <u>DELGAMUUKW</u> is probably something that would be looked at at the federal level in Ottawa at our national headquarters. That's how my job is affected" -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles
- "We want the RCMP's position on DELGAMUUKW to be brought to us here before you start enforcing any more laws" -- WLIB MEMBER

"What laws do I enforce that you're not happy with? I enforce the criminal code, the motor vehicle code..." -- CTC / WLIB / RCMP Native Puppet Constable Bruce Belleau Coles

"Put it this way then. Which ones are you supposed to enforce?" -- WLIB MEMBER

"If there is unauthorized harvesting going on it has the potential of jeopardizing our relationship with the band and government relationships with the treaty process" – MOF Regional Manager Mike Carlsen (Cariboo Forest Region)

#### "Harvesting must be authorized"

"Timber harvesting has to be approved by the Ministry of Forests.

That's the message from Mark Hamm, Ministry of Forests Aboriginal Affairs Manager in response to comments last week ("Timber harvest unauthorized," *Tribune* March 9) that the Forest Act allows First Nations people to harvest timber for building houses on reserves.

Harvesting of timber by First Nations people is illegal unless it falls under the category of 'traditional and cultural activity,' states Section 48 (1) (g) of the Forest Act. Traditional and cultural activities are described as: totem poles, dug out canoes, wooden utensils, fishing pens, smokehouses, wood for carving, apple boxes, coffins, and firewood required for a community cultural event.

'First Nations have no specific right to harvest timber specifically for housing,' says Hamm. He went on to clarify the regulations stating that they required authorization from the ministry in the form of a free – use permit. These permits are given to groups only and not individuals.

The permit allows for harvesting of up to 250 cubic metres of timber for the construction of longhouses or community building, not residential houses.

#### \*\* SUBJECT OF DISCUSSION: September 28, 1999 Logging Issue at Harper Lake \*\*

"...the bands said, of course, these are Aboriginal Trees, we have an interest in these trees and the constitutional question as to who owns these trees was raised in those cases and that's what the "unauthorized" logging cases are about. There are two critical points that we're fighting with the province about in the logging cases and there have been a number of technical maneuvers that we've gone ahead with and that the province has gone ahead with. We're trying to get to the courts...we're trying to make two very important points to try to implement DELGAMUKW...one of the points we're trying to make in the court is if the province wants to stop Aboriginal Peoples from exercising their right to the resources, then the province must come to court with either evidence the people don't have Aboriginal Title or evidence that they have accommodated and can justify their conduct (wanting to stop the people from logging), so that the onus shifts, not for Aboriginal People to prove their title, that's what the province wants, they don't want to talk to any Aboriginal People about anything until the title is proved in court. We're saying to the court "No, if the province wants to stop Aboriginal People, they have to show, the province must show, either that Aboriginal Title doesn't exist or that the Crown acted properly and their conduct has been that of a fiduciary, they have consulted, they have given priority to the Aboriginal 'interest' and so on." The second point we're trying to make in these cases is to challenge the Forest Act and the Forest Code to say 'When the province, and this would be true for the Federal government as well, when legislation is passed, where there is a risk that Aboriginal Title or Rights will be infringed, then the legislation itself must set out how District Managers or other Decision Makers, how bureaucrats are going to accommodate Aboriginal Title. It can't be just left to a District Manager to make any decisions without any criteria in the legislation that gives some guidance to the exercise of that discretion so if a District Manager is going to make decisions about issuing licenses for cutting, then there would be in the Forest Act itself how it is the District Manager must first accommodate Aboriginal Title before that license can be issued' This argument comes from the Supreme Court of Canada decision in a case called ADAMS. It said that 'Where Aboriginal Title and Rights are concerned, you can't have UNSTRUCTURED DISCRETION. People making decisions, government officials making decisions that affect these constitutional rights without some guidance in the legislation We're saying the Forest Act & Code are no good because they fail to do that. So those are sort of the two loggerhead points where we've joined issue with the province. The province's strategy in all of these cases is to use the courts to say; Aboriginal People must prove their title, they must do this in a trial that will take a long time, it will require lots of evidence the province needs a lot of time to get their evidence together, so its to delay the ultimate from happening, they don't want to face existing Aboriginal Title and so all of their moves in the court have been to stretch this out, to not get to the constitutional question, to require a trial where the people are required to prove their title. To keep the uncertainty alive. All the while they're issuing cutting permits and so on and so forth. I think I'm going to skip over some of what I was going to say and just say this: I think everybody knows and I think the province knows that ultimately, they will have to deal with existing Aboriginal Title. They will have to reach agreements with Aboriginal People about the land and about the resources, and I don't think it's in their interest to be delaying it but that's where we are at the moment and our iob is to continue to educate the judges to call the province on to make sure the judges see what the province is trying to do and avoiding the implementation of <u>DELGAMUUKW</u> and making it impossible for Aboriginal Nations to conclude agreements with the province given the province's position" - Chloe Ostrove, Mandell / Pinder

"There was an article in the local paper (Kamloops Daily News, March 22, 2000) saying that the court ruled against what happened at Harper. What are the implications of that?"

"There have been a number of efforts by the bands to try to get the court to hear the real dispute between the parties which is the constitutional question which is who ...can the province simply do what it wants with the trees without reference to Aboriginal Title and one of the ways we tried to get the court to hear...that is to...let me back up. The province says 'We first have to prove in the court, Aboriginal Title, bring all the evidence Doug was talking about that was done in <u>DELGAMUUKW</u> to show: What the Aboriginal Title..., what the nature of it is. What does it look like? What rights do we claim?' Then the court can hear the constitutional argument and what we've been trying to do is bring forward arguments, using the rules of court to simply get the court to hear the constitutional question because there is existing Aboriginal Title whatever the evidence of it is. There is existing Aboriginal Title. So we don't want to spend years of time and money and so on going through a DELGAMUUKW kind of trial and we don't think it's necessary. So one of the things we said to the judges was 'Let us just hear one... just have the court hear one constitutional point of law without the necessity of having to prove, bring forward all of this evidence, take all of this time to prove Aboriginal Title' The judge said 'NO, THAT HIS VIEW OF THE LAW IS THAT WE DO HAVE TO FIRST BRING FORWARD ALL THE EVIDENCE OF ABORIGINAL TITLE. That it wasn't appropriate to hear a simple question of law', which is what we were saying, that would solve the matter in isolation from the evidence of Aboriginal Title. So what was lost was the ability of proving Aboriginal Title. Again, as I said this morning. I think this is part of the reason the province (BC) is opposing our efforts to bring forward the issue quickly is because they don't want to deal with the judgment. They want to delay this as much as they can and not have a judgment that recognizes Aboriginal Title in this area" – Chloe Ostrove, Mandell/Pinder

CITY SCENE - "Co - management plan in treaty talks" - Angie Mindus, Tribune Staff Writer

"According to statistics included in CTC'c presentation, the Northern Secwepemc te Qelmucw is growing at a rate of 3 times faster than that of Williams Lake residents. About 60% of the NSTQ people live on reserve and the chiefs anticipate many more will move back once a 'treaty' is finalized.

'Our housing needs are exceeding the land base we have,' (Chief Larry) Camille said of the Dog Creek reserve.

Current NSTQ reserve lands amount to approximately 10,000 hectares while their claimed traditional territory makes up about 38,228,400 hectares. The CTC said the NSTQ live on about 0.03 % of their traditional territory.

As well as the differences they encounter at the treaty table, chiefs of the four bands are also facing pressure within their own community as members grow increasingly frustrated with the slow pace of negotiations.

'From my perspective, I'm personally getting frustrated,' (Chief Antoine) Archie said. 'The BC 'treaty' process is in trouble. There are a lot of people who aren't happy with it.'

That speculation became evident at last week's meeting when Williams Lake Indian Band member Arnie Jack interrupted negotiation talks in an attempt to convince observers not to participate in the process. Jack, known as a radical in the band, logged trees in the Spokin Lake area without the government's or the band's consent last month and has plans to start up again soon."

#### Section I Introduction

- "The Northern Secwepemc te Qelmucw Land Use Plan (NStQLUP) is a compilation, interpretation and presentation of <u>years</u> of land use information gathered by the CTC't'S, member bands, Provincial Ministries and current internal and external studies"
- "Other land use plans were surveyed and analyzed before developing the model and format for the NStQ Land Use Plan. Among others the Cariboo Chilcotin Land Use Plan (CCLUP) and the Xay Temixw Land Use Plan (Squamish Nation) were considered as relevant studies. CCLUP has local significance and Xay Temixw LUP is significant as a Land Use Plan from a First Nations perspective. Both were useful is developing a model for the NStQLUP"
- "This plan represents the Aboriginal Rights and Title of the NStQ. It has been developed to provide a tool to assist in the reconciliation of Crown Title (sic) and Aboriginal Title. The NStQ have been working towards this reconciliation for many years. The NStQ Land Use Plan is simply a tool to promote the effective advancement of this goal"
- "We, the Northern Secwepemc do not wish to go to court due to the cost and the fact that someone else decides the end result"

#### Section 2 NStQ Land Use Plan

"management of urban and fee simple land is *not* within the scope of this land use plan"

- "Starting in August 2001, workshops were conducted at each of the four NStQ communities to gain input from the community members. Each community was visited twice to introduce the land use plan and identify goals in relation to the social, environmental and economic influences on Secwepemcul 'ecw'
- "CTC't'S and CTC RIMS carried out the Land Interest Project { LIP -Tab F is Forestry } in 1999 / 2000. This project involved extensive community consultation. Meetings were held at Working Groups, Family Meetings, General Band Meeting and Workshops"
- "On April 30, 2001 twenty two participants from the NStQ communities and staff came together for a two day workshop hosted by the CTC. The purpose of the workshop was to discuss the future of land and resource use in the Sewepemcul 'ecw"
- "Involvement in the AIP process has produced a large body of work. Most of the technical is carried out by the Natural Resources Technical Working Group (NRTWG), Side Table Working Group (STWG) and CTC Technical Working Group. Completed Interest Papers, Principles Checklists and Chapters are available at CTC and the 4 communities and provided background information and direction for the Land Use Plan"

#### Section 3 Aboriginal Title and Rights of the NStQ

- "The NStQ have never ceded or surrendered title to their lands, right to the resources, or jurisdiction over the decision making within Sewepemcul 'ecw"
- "The total population of the NStQ is 1,911 with a current growth rate of 3% annually (as compared to a local non First Nations growth rate of 1.9%)"
- "Sewepemcul 'ecw is 38,284 square kilometers of mountains, valleys, rivers and lakes that have sustained the NStQ for thousands of years (NStQ Statement of Intent Map)"
- "Webster's Dictionary defines community as {a body of people living in the same place under the same laws}"

#### Section 4 Aboriginal Rights and Title and the Crown

- "The DELGAMUUKW decision stated that land reserved for First Nations includes not just reserves but land where aboriginal title exists"
- "Aboriginal Title can only be transferred, sold or surrendered to the crown. To establish title, the land must have been occupied before British Sovereignty in 1846, and continuity of occupation is an important factor. According to <u>**DELGAMUUKW**</u>, Aboriginal Rights may be infringed with justification only to further valid legislative objectives such as conservation and public safety"
- "to accept and confirm DELGAMUUKW and enact changes in legislation and policy in accordance with that decision"

#### Section 5 Vision, Principles and Goals

- "All of the NStQ Traditional Territory is and will remain Secwepemcul 'ecw'
- "Provide a strategy for commercial, residential and industrial development necessary to meet the NStQ social, cultural, environmental and economic requirements"

#### **Section 6 Land Use Strategies**

- "The forests of Secwepemcul 'ecw provided housing, shelter, tools, medicine and food. They provided essential wildlife habitat and were an integral part of the NStQ cycle of life. Currently the Forest Industry has the largest cultural, environment and economic impact on Secwepemcul 'ecw. A detailed review of the current provincial forest management practices is necessary to identify the issues and objectives of the NStQ in regards to forestry"
- "One quarter of the land in the province is used as the working forest area"

- "ISSUE Continued exclusion of NStQ from profits from timber resources in Secwepemcul 'ucw"
- "Access timber for existing and future forestry, value added business and community infastructure"
- "In 1860 the Pre emption Act was developed that allowed a settler to claim 160 acres for agricultural development with an option for another 320 acres if certain conditions were met"
- "Secwepemcul 'ucw has some of the best agricultural land in BC. There are 189 grazing leases covering a total of 45,774 hectares"
- "The NStQ will also seek areas where there is minimal conflict to existing land uses. Privately owned land will only be identified if there is willing buyer / willing seller potential"
- "The current population growth rate of the NStQ is 3% nearly double the rest of BC. At this rate of growth the NStQ population will double in approximately 27.5 years"
- "Currently there is a back log of housing for the NStQ population. This will need to be addressed in the short term. If the population is going to double then the NStQ will need to identify lands to accommodate this population growth. The main barriers to meeting the NStQ housing needs are funding and material to build the houses and space for housing development. The following strategy will guide community expansion to meet the NStQ requirements"

#### **Section 7 Land Use Areas**

- "The NStQ identifies five Land Use Areas: Stewardship Areas, Sensitive Areas, Wilderness Areas, Parks and Protected Areas and Settlement Areas"
- "The WLIB conducted a TUS on the Penfold area in 1996. This study cited ethnographer James Tait as identifying the area as being exclusively owned by NStQ, specifically by the WLIB and SCIB. This was confirmed by the interviews taken during that TUS study. The area has a large amount recorded and unrecorded archaeology sites and has been used for thousands of years for hunting, gathering and ceremonial uses"
- "Farewell Canyon is located west of the confluence of the Chilcotin and Fraser Rivers. It is a major traditional and fishing site of the NStQ, an ancestral village site lies within the sensitive grassland ecosystem (BG)"
- "Ts'peten (Gustafsen Lake) Wilderness Area is located approximately 30 km east of Dog Creek. This area has significant cultural and environmental value. Archaeology sites include pit house depressions, lithic scatter and culturally modified trees. Traditionally it has significance as a gathering place, hunting grounds and seasonal village site"
- "In general the NStQ Land Use Plan will not affect private land and fee simple land"

#### **Section 8 Economic Development Strategies**

- "The NStQ require an economic base to support governance, develop human resources and prosper. In 2001 Growth Strategies International (GSI), jointly sponsored by the CTC 'treaty' Society, the Ministry of Aboriginal Affairs of BC and the Department of Indian and Northern Affairs produced a regional economic development study. This study identified opportunities and provides a framework for the NStQ to develop an economic base"
- "Another relevant study is the <u>Harvard Project on Indian Economic Development</u>. This study is an extensive American based research project that has analyzed American Indian Bands with successful economic development and what they had in common. The Harvard project is known as the best study of success in Indian Economic Development and no such research has yet to be done in Canada"
- "Successful bands are ones that have acted as sovereign nations H.P.O.I.E.D"
- "8.2 Forestry and Value Added Wood Products: This is the sector with the greatest potential identified for the NStQ"
- "Objective 1 Promote and facilitate the development of new forestry and value added wood projects"
- "Strategies 1 Implement the forestry strategies outlined in Section 6"
- "Strategies 7 NStQ communities build capacity in all aspects of value added wood products from harvesting timber to retail and wholesale of value added products"

#### Section 9 Implementation of the plan

- "Internal capacity building is essential to the implementation of the plan. Capacity building will require development of human, political and economic resources"
- "Building self esteem and overcoming social problems in the communities is essential to the implementation of the NStQ Land Use Plan"
- "Following the recommendation of the Economic Development Study done by Growth Strategies International, and the economic development strategy in Section 8, strategic plans must be developed at the community level. These plans will identify the obstacles and opportunities faced by the communities and provide a course of action to overcome the obstacles and capitalize on the opportunities"
- "The NStQ are currently negotiating MoUs with the Ministry of Forests"

#### **Section 10 Definitions**

- "Aboriginal Right The right of a First Nation to perform activities on their traditional territory"
- "Aboriginal Title Full jurisdiction and ownership of a traditional territory by a First Nation"
- "Cede To give, surrender or yield by necessity"

- "Infringement To interfere with ability of a First Nations Aboriginal Title and Right"
- "Jurisdiction The power, right, or authority to interpret and apply the law and the limits or territory within which that authority may be exercised"
- "Reconcile To make opposing or conflicting interests consistent or congruent"
- "Secwepemc Literally translates to {People of the spread out place}. Refers to all 17 bands of the Shuswap Nation"
- "Secwepemcul'ecw Úsually refers to all of Secwepemc territory. In this document it refers only to the northern portion {NStQ Statement of Intent}.

"More than 60 participants sat down and rolled up their sleeves Thursday, April 25 to consider the next steps needed to formulate 'treaties' and understandings in the Cariboo – Chilcotin. The session was funded by the BC 'treaty' Commission and co – hosted by the Northern Sewepemc te Qelmucw, the Cariboo – Chilcotin Regional 'treaty' Advisory Committee, the local SHARE group, and the City of Williams Lake"

"Assistant provincial negotiator, Nancy Bircher, and assistant federal negotiator Deb Wilson also joined in discussion with Cariboo residents"

"It was no accident that the session started without a set agenda, as the day's topics were formulated by those in attendance. Known as an open space meeting, the agenda was developed as people brought ideas that mattered to them forward. Then dialog groups comprised of individuals with a shared interest in an issue, carried on focused discussions"

"Open space meetings with no predetermined agenda were developed from the idea that traditionally, at many conferences, the best discussion often happens at the coffee breaks' facilitator Chris Corrigan explained to the group"
